Status of lake report – Progressive AE

Rick Buteyn, Progressive AE reviewed the 2023 Project Work Journal detailing the lake surveys, chemical applications and weed harvesting including treatment and harvesting maps of Long Lake. Additionally, water quality data from 1993 to 2023 was provided.

Rick addressed board questions about earlier treatments of Starry Stonewort explaining using copper sulfide herbicide is prohibited until August. There is an additional contact herbicide Flumioxazin (Clipper, ~~Scotter~~ Schooner, Propeller) that could be applied earlier which may reduce the growth of Starry Stonewort. Responding to 2023 harvesting concerns, additional areas could be harvested in 2024 if the board agreed to the additional expenses.

EGLE Water Monitoring

Micheal Keast informed the board he applied to EGLE, Water Resources Division for Water Quality Monitoring for Long Lake. He will update the board when he is notified of their decision.
