Discuss Lake Management Treatment Plan

Rick Buteyn, Progressive Companies reported the results of the May 13th weed survey noting less Eurasian Milfoil and more Curly-leaf Pondweed and native weeds than last year's initial survey. The mild winter and lack of ice have not resulted in early or increased growth of the non-native plants. The effectiveness of the systemic herbicide used last year to treat Eurasian Milfoil will allow the treatment of smaller areas with smaller amounts of herbicides in 2024. The first treatment for milfoil and curly-leaf pondweed is scheduled for the week of May 20th with an additional application in August.

Treatment using Flumioxazin (Clipper) for Starry Stonewort close to the shore and docks is scheduled for mid to late June.

Mechanical harvesting of starry stonewort and nuisance native plants is scheduled for mid-July. With the anticipated savings for the decrease in herbicide treatments, additional areas may be included in the harvest.

Public Comment

Gary Knoerl questioned what could be done to control the seagulls gathering on the lake in August, noting his concern about the amount of E. Coli.
